PROFIT WARNING ANNOUNCEMENT

This announcement is made by Nomad Technologies Holdings Limited (the “**Company**”, together with its subsidiaries, collectively the “**Group**”) pursuant to Rule 17.10 of the Rules Governing the Listing of Securities on the GEM of The Stock Exchange of Hong Kong Limited (the “**GEM Listing Rules**”) and the Inside Information Provisions (as defined under the GEM Listing Rules) under Part XIVA of the Securities and Futures Ordinance (Cap. 571 of the Laws of Hong Kong).

The board (the “**Board**”) of directors (the “**Directors**”) of the Company wishes to inform the shareholders of the Company and potential investors that based on a preliminary assessment by the Board with reference to the unaudited management accounts of the Group for the six months ended 31 December 2020 and the information currently available to the Board, the Group is expected to record a net loss before listing expenses of approximately RM0.5 million for the six months ended 31 December 2020 as compared to the net profit before listing expenses of approximately RM3.4 million for the six months ended 31 December 2019.

The Board considers the expected net loss before listing expenses for the six months ended 31 December 2020 is mainly attributable to:

- (1) a decrease in revenue of approximately RM1.3 million due to, among other things, the prolonged adverse impact caused by the COVID-19 and the relevant nationwide “movement control order” in Malaysia;
- (2) a decrease in gross profit margin from approximately 41.0% for the six months ended 31 December 2019 to approximately 32.3% for the six months ended 31 December 2020 due to the increase in the cost of telecommunication and network subscription and the increase in the cost of network equipment and hardware;
- (3) an increase in administrative and other operating expenses of approximately RM2.5 million due to the increase in depreciation of property, plant and equipment and the increase in the amount of recognition of unrealised net foreign exchange loss.

The Company is still in the process of finalizing the interim results of the Group for the six months ended 31 December 2020. The information contained in this announcement is only based on a preliminary assessment by the Board with reference to the unaudited management accounts of the

Group for the six months ended 31 December 2020 and the information currently available to the Company, which may be subject to change and is not based on any figures or information that have been audited or reviewed by the Company's Auditors nor reviewed by the Audit Committee of the Board. The actual financial results of the Group may be different from what is disclosed in this announcement. Details of the Group's results will be disclosed as and when the interim results of the Group for the six months ended 31 December 2020 is announced in accordance with the GEM Listing Rules.

Shareholders of the Company and potential investors are advised to exercise caution when dealing in the shares of the Company.
