### **INSIDE INFORMATION DISPOSAL OF SHARES BY SUBSTANTIAL SHAREHOLDER**

This announcement is made by Nomad Technologies Holdings Limited (the “**Company**”) pursuant to the Inside Information Provisions under Part XIVA of the Securities and Futures Ordinance (Chapter 571 of the Laws of Hong Kong) and Rule 17.10 of the Rules Governing the Listing of Securities on GEM of The Stock Exchange of Hong Kong Limited (the “**GEM Listing Rules**”).

#### **DISPOSAL OF SHARES BY SUBSTANTIAL SHAREHOLDER**

The board of directors of the Company (the “**Directors**” and the “**Board**”, respectively) has been informed by Robust Cosmos Limited (“**Robust Cosmos**”) on 28 September 2021 (after trading hours) that Robust Cosmos has disposed of an aggregate of 33,750,000 shares in the Company (the “**Shares**”) to Garden Wealth Limited (“**Garden Wealth**” and the “**Purchaser**”) at a total consideration of HK\$6,750,000 (the “**Disposal**”).

Robust Cosmos is beneficially owned by Ms. Kwong Shir Ling, who is the spouse of Dato’ Eric Tan Chwee Kuang, the Executive Director of the Company. Prior to completion of the Disposal, Robust Cosmos held 33,750,000 Shares, representing 5.625% of the issued share capital of the Company. Immediately following the Disposal and as at the date of this announcement, Robust Cosmos ceased to be a shareholder of the Company.

Upon the completion of the Disposal and as at the date of this announcement, Garden Wealth holds 33,750,000 Shares, representing 5.625% of the issued share capital of the Company.

#### **INFORMATION OF THE PURCHASER**

To the best of the Directors’ knowledge, information and belief having made all reasonable enquiries, the Purchaser is an investment holding company incorporated in the British Virgin Islands and its ultimate beneficial shareholders are Ms. Guo Xingxin (“**Ms. Guo**”) and Mr. Jiangbin (“**Mr. Jiang**”) who indirectly owns 68.4% and 28.6% equity interest in Garden Wealth, respectively. Ms. Guo and Mr. Jiang are merchants and are independent of and not connected or acting in concert (as defined in the Hong Kong Code on Takeovers and Mergers) with any connected person of the Company and its subsidiaries immediately prior to completion of the Disposal.

The Company does not expect that the Disposal to have any significant impact on the operations of the Company and its subsidiaries and the composition of the management of the Company.
