PROFIT WARNING ANNOUNCEMENT

This announcement is made by Nomad Technologies Holdings Limited (the “**Company**”, together with its subsidiaries, collectively the “**Group**”) pursuant to Rule 17.10 of the Rules Governing the Listing of Securities on the GEM of The Stock Exchange of Hong Kong Limited (the “**GEM Listing Rules**”) and the Inside Information Provisions (as defined under the GEM Listing Rules) under Part XIVA of the Securities and Futures Ordinance (Cap. 571 of the Laws of Hong Kong).

The board (the “**Board**”) of directors (the “**Directors**”) of the Company wishes to inform the shareholders of the Company and potential investors that based on a preliminary assessment by the Board with reference to the unaudited management accounts of the Group for the three months ended 30 September 2021 and the information currently available to the Board, the Group expects to record a net loss of approximately RM1.0 million for the three months ended 30 September 2021 as compared to the net loss of approximately RM7,000 for the three months ended 30 September 2020.

The Board considers the expected net loss for the three months ended 30 September 2021 is mainly attributable to:

- (1) a decrease in the gross profit margin from approximately 36.9% for the three months ended 30 September 2020 to approximately 29.0% for the three months ended 30 September 2021 mainly due to the increase in the cost of telecommunication and network subscription; and
- (2) an increase in the administrative and other operating expenses of approximately RM0.9 million due to (a) the increase in depreciation of property, plant and equipment, (b) the increase in staff cost for administrative and management personnel (including Directors) and (c) the increase in the cost of repairs and maintenance of property, plant and equipment.

The Company is still in the process of finalizing the first quarterly results of the Group for three months ended 30 September 2021. The information contained in this announcement is only based on a preliminary assessment by the Board with reference to the unaudited management accounts of the Group for the three months ended 30 September 2021 and the information currently available to the Company which may be subject to change and is not based on any figures or information that have been audited or reviewed by the Company’s Auditors nor reviewed by the Audit Committee of the Board. The actual financial results of the Group may be different from what is disclosed in this

announcement. Details of the Group's financial results will be disclosed as and when the first quarterly results of the Group for the three months ended 30 September 2021 is announced in accordance with the requirements of the GEM Listing Rules.

Shareholders of the Company and potential investors are advised to exercise caution when dealing in the shares of the Company.
